- 2 foot with 2 counterweight with reference CB2PA
- 2 central foot with 1 counterweight with reference CB1PA

The railguard was made up of three identical lengths of 1500 mm. With 1100 mm high. It's installed against upstand.


IV. REFERENTIEL
